

# BENEFITS

#### **Health Insurance**

EnTech offers three health insurance plans through Meritain Health, a subsidiary of Aetna, that utilizes the Aetna PPO network. EnTech pays 65% of the monthly plan premiums for employees and their families.

#### **Health Savings Account (HSA)**

HSAs allow employees to set aside pre-tax dollars to pay for eligible medical, dental, or vision expenses. EnTech contributes up to 50% of the annual HSA allowance for employees enrolled in the EnTech high deductible health insurance plan.

#### HealthiestYou (Telemedicine)

Low cost doctor consultations are available 24/7/365 to employees and their families enrolled in EnTech health insurance.

#### Vision & Dental Insurance

EnTech offers Guardian vision and dental insurance at no cost to the employee and their families plus the option to purchase additional dental insurance for oneself and one's family.

#### Flexible Spending Account (FSA)

FSAs allow employees to set aside pre-tax dollars to pay for eligible medical, dental, vision, and/or child/dependent care expenses.

## Short-Term & Long-Term Disability

Short-Term and Long-Term Disability insurance is offered at no cost to the employee.

#### Life Insurance

EnTech provides life insurance at no cost to the employee, plus the option to purchase additional insurance for oneself and one's family.

#### **Transportation Benefits Program**

Employees have the option to set aside pre-tax dollars to pay for eligible commuting and parking expenses.

#### 401(k)

EnTech offers a 401(K) retirement plan through Principal. Employees are eligible to participate after 90 days of employment. EnTech matches 100% of employee contributions up to 4% of the employee's annual gross income.

#### **Health Club Membership**

EnTech pays a portion of the employee's New York Sports Club membership costs.

#### Vacation and Sick Leave (VAS)

Full-time employees receive 15 days (120 hours) of paid, combined VAS leave per year, which accrues weekly. After each full year of employment at EnTech, the VAS accrual rate is increased by one day (8 hours) per year.

## **Professional Development**

EnTech recognizes the value of professional development and personal growth and may assist with the cost of maintaining job-specific certifications, licenses, and training.
